1. Membership Overview

Books & Bars Club is a women's social and literary community based in Toronto offering curated events, social gatherings, member perks, and community access.

Membership includes access to various benefits depending on your membership tier.

Benefits, events, and perks may evolve over time as the community grows.

2. Membership Tiers

Monthly Membership

- Billed at **\$19.99 CAD/month**
- Renews automatically each month
- Cancel anytime before your next billing cycle

Annual Membership

- Billed at **\$155.88 CAD annually** (equivalent to \$12.99/month)
- Membership commitment is for **12 months**

- Automatically renews every **12 months** unless cancelled prior to renewal

Books & Bars reserves the right to adjust pricing for future memberships. Existing memberships will retain their current pricing unless otherwise communicated.

3. Membership Benefits

Membership benefits may include:

- Free access to monthly Plot Party events
- Access to our WhatsApp community
- Complimentary member-only events (e.g., movie nights, author events, etc.)
- Priority access to select events
- Member discounts and partner perks
- Exclusive monthly newsletters and offers
- Community experiences and curated social events

Please note that certain events may still require separate ticket purchases.

Benefits and partner offers are subject to change at any time.

4. Cancellation & Refund Policy

Membership fees are **non-refundable** once charged.

Monthly memberships may be cancelled at any time before the next billing cycle.

Annual memberships are non-refundable once payment has been processed and remain active for the duration of the 12-month term.

Membership pauses may be granted at the discretion of Books & Bars Club.

5. Event Ticket Policy

Certain events may require separate ticket purchases.

Event tickets are **non-refundable**.

If you cancel attendance **72 hours or less before an event**, a cancellation fee may apply.

This policy helps us fairly manage reservations, venue commitments, and waitlists.

Tickets may be transferable on a case-by-case basis.
